WOMEN EMPOWERMENT PROGRAM

The program covers 6500 women belonging to 488 Self-Help Groups (SHGs) in 50 Grama Panchayats in Chitguppa, Humnabad, Aurad, Hulsoor, Balki, Bidar, and Basavakalyan taluks of Bidar district. The target groups of the program include rural women and adolescent girls.

Objectives

- Improve the level of literacy of adolescent girls and women
- Increase the number of trained women in book keeping of Self Help Groups (SHGs) of women
- Strengthen women with knowledge and awareness of basic rights of their own, their families and villages
- Reduce the number of women and adolescent girls with ignorance on nutrition, health and sanitation
- Promote Cluster and district level federations for economic self-sustainability of SHGs
- Educate women on enhancing livelihood through entrepreneurship

1. With Strengthened Wings:



Rukmini is 48 years old flour mill owner in Kaudiyal village of Basavakalyan Taluk in Bidar District. She is a well-known and well-accepted woman in the village.

This was not the identity of Rukmini, a few years ago. She hails from the Gonda community of Scheduled Tribes; an illiterate woman who got married in her teenage (Child marriage) as was the custom of the locality. Soon she became the mother of four children – two sons and two daughters. Rukmini and Ramesh earned their livelihood working as agricultural laborers. They also cultivated the little piece of land they had growing maize and toor peas for consumption.

As the children began growing up, the family expenses also increased. Poverty marked their family as seasonal agricultural labor and wages are low. Meanwhile, Rukmini observed the women of the village being formed into Self Help Groups (SHGs) by ORBIT staff. She was attracted by the idea of saving a little from her trifle income and being helped by lending loans in time of need. Thus, she became a member of Om Shakti SHG in her village, 15 years ago.

The experience of becoming part of SHG, attending meetings and trainings on various topics, savings, mingling with other women... was altogether a new world for her. From being a young woman confined to her family and community alone, Rukmini was formed into a courageous and confident leader. The group atmosphere encouraged her too.

Though her income was limited, she was punctual in her savings. It enabled her to take loans from the SHG to educate her children. She has been convinced of the value of education and wanted her children to be educated.

Gradually, Rukmini has been able to take loans from the bank for various purposes such as Rs. 35,000/- for children's education; Rs. 40,000/- for powdering machine; and rs.58,000/- for the flour mill. Besides that, she was able to get a loan of Rs.2,00,0000/- for her and other three members (Rs. 50,000/- per member) from Gram Panchayat for self-employment.

Presently, Rukmini has become a confident woman who is actively present in all the social gatherings of her village; helpful for others in their needs. She is also planning to contest in the coming election. She educated all her children. Eldest son completed his ITI and is employed in Bangalore since 2021. Both the daughters completed their bachelors' degrees and are settled. Youngest son is doing his Pre-University Course.

Rukmini earns average Rs. 300/- as profit per day from her flour mills (grains and masala mills). She constructed her house and her standard of living is improved.

2. Emerging Leadership for Local Governance through Self Help Group

Sangeeta Sunil is 28 years old woman from Bhatambra village of Bhalki Taluk. She is educated up to SSLC. Sangeeta had child marriage as it is prevalent in the Bidar district. She fell in love with Sunil, her neighbor from the same village. She got married to Sunil (who was 19 years old), as soon as she completed her SSLC in 2010. Sangeeta was 17 years old at the time. Sunil studied up to 7th standard. The couple has two children – a son (11 years) and a daughter (9 years). Their life was quite hard as they depended on the wages of their daily labour and did not have any other income. They live in a small two-room house with a tin- roof. Sangeeta did not have much contact outside.



At this juncture, she observed the other women in the village having Self-Help Group meetings and being helped. So she decided to join the SHG. When she expressed her desire, she was encouraged by the animator of ORBIT who facilitated the SHGs. Thus, Sangeeta became a member of Pragati SHG under ORBIT in 2018. She began to save money in the group and took loans to educate the children and for other needs.

She participated in the awareness programs organized for the SHG members and acquired information on Panchayati raj, health, leadership, etc. and learned about the schemes and entitlements

available from various departments. Her social life expanded as she interacted with other members and visited the departments. She related with everyone amiably and the people liked her approach.

During the local governance election in December 2020, Sangeeta decided to contest from her ward. The SHG members, ORBIT animator, and the local Coordinator encouraged Sangeeta to contest and serve her village. She took Rs. 60,000/- from the SHG for the expenses of the election campaign. Pragati SHG members campaigned for her and she won the contest and has become one of the members of Bhatambra Gram Panchayat. Sangeeta is proving that she is a real representative of her people by addressing the issues of basic amenities of her village by constructing the drinking water tanks; repairing and improving the water supply system; street lights, etc. She is fulfilling the dreams of the people who elected her. She ensures that every family in the village is benefitting from the MGNREGA scheme.

She is grateful to ORBIT for the social and political empowerment in her life.

Case study:1 Rescue of children in Bonded labour



On 24.11.2021, child helpline 1098 received a call informing about three children working as bonded labourers in a family, at Nirnawadi village of Chitguppa Taluk. The child line team visited the village and collected information from the anganwadi teacher and confirmed that the information was correct.

Mr. Devinder and Sunanda from the Scheduled Tribe community have four children - three sons and a daughter. The eldest son is 12 years old Vivekanand, the second one11 years old Vishwanath, the third one is 9 years old Venka and the youngest one is 5 years old Vidyavathi studies in 6th, 4th, 2nd and Anganwadi respectively. Devinder is a drunkard and tortures his wife regularly. Both the couple is coolie workers. Due to the COVID - 19 pandemic and consequent lockdowns, the couple did not have much work and struggled to meet their ends. They began to borrow from people.

Being a very poor family and having borrowed money (Rs. 30,000/-) from a landlord of the village, Devinder failed to repay the debt. He began to send his children to work in his land.

The child line team visited the house of the land owner and saw Vivek going with the buffalos to graze. They questioned the employer who is a bill collector in the gram panchayat and conscientious him about the rights of the children and the legal and social consequences of child labour. He promised not to engage the children in child/ bonded labour. The team took the children to school and discussed with the Headmaster. Children were given books and placed in their respective classes.

The follow-up visits ensured that the children were continuing their studies; parents want them to be in school and if needed, ready to admit to the hostel.

Case study:2 Drinking Water issue in the school

"Open House Programme" under Childline Project was conducted in Government High School, Kudambal, Chitguppa Taluk on 24.9.2021. The rights of children, the care and protection available for the children when their

rights are violated and the toll-free child helpline 1098 was introduced to the children. During their discussion, the children brought out the issue of the non-availability of drinking water in the school campus. Panchayat President and Secretary who were present in the Open House Programme promised to solve the issue. But no action was taken on their part.

The Childline team member followed up the case. He formed the Children's group in the school consisting of 15 students from 8th, 9th, and 10th standard and motivated the children to get their rights.

Thus, on 21.10.2021, the children made a call to 1098 requesting to solve the drinking water issue in the school.

The Childline team member visited the school, studied the status of the drinking water supply, and discussed with the headmaster about the issue. Based on the information collected, a letter was submitted to the Panchayat Development Officer (PDO), Kudambal, Block Education Officer (BEO), and Block Resource Coordinator, along with the pictures of the disconnected water tank and bore well.

The team member contacted the Panchayat President over the phone and reminded them to rectify the water supply; visited the PDO (mean while the old PDO was transferred and



a new one had taken charge) and followed up on the issue.

Finally, after a month of the Open House House Programme, the drinking water issue in the school was solved. The pipe connection from the bore well to the water tank and the supply connection from the tank to the taps were re-established and the damaged water pipes were replaced.

WOMEN IN MICRO ENTERPRISE

In collaboration with SAMRUDI - Rural Upliftment Foundation, Bangalore, this program is organized by ORBIT in Bidar, Balki, Basavakalyan, Chitguppa, Hulsoor, and Aurad taluks of Bidar district. Members of mocratically governed women's organizations own and control SAMRUDI. The program envisages creating entrepreneurs among rural women to improve the standard of living of their families

CASE STUDY

50 years old Bharatbai is an illiterate woman from the Bannalli village of Chitguppa Taluk. Hailing from a Scheduled caste community and not having much land and property, she and her husband Ismail worked hard to overcome their poverty. They worked on the one-acre land they owned as well as worked as agricultural laborers in other farmers' fields. Sometimes, they took other fields on lease and cultivated them too.



They lived in a small hut and brought up their four sons. Though illiterate, the parents were concerned about the education of their children. They placed the elder sons in some of the rich people's houses and boardings so that they could get educated.

Bharathi bai joined Navashanthi SHG under ORBIT in her village, from its inception in 2005 onwards. The regular savings in the SHG enabled her to avail of loans on necessity. It was a great help for her especially when she struggled to pay the fees of her eldest son who was doing his MSc. She also availed of Samrudi loans through the SHG and bought buffalos. It ensured regular income for the family though she had to work hard.

The hardworking couple leased land and began cultivating too. They saved the income and with the loans from SHG and other sources, constructed a beautiful and spacious concrete house. It was completed in 2020.

Presently Bharatibai invested her income from the sale of buffalos in sericulture which brings more income. They got the sericulture shed and the mulberry plants garden for sericulture on lease. Her husband and children are actively working with her for the enterprise as it needs many hands and a lot of attention. She has an average profit of Rs. 1,00,000/- after reducing all expenses.

The eldest son completed his MSc and is placed in the Taluk office; the second son completed his PUC and is a successful fruit merchant in Hyderabad; the third son did his Diploma in Agriculture and has been helping the parents in farming. Presently (2022 March), he is appointed as farm manager by an estate owner. The youngest son has written the final exam of SSLC. He too is highly interested in farming and helps his parents. Bharatibai's life and her family have benefitted from the economic and social growth through the self-help group and Samrudi loan.

COMMUNITY-BASED REHABILITATION (CBR)

CBR Program for the differently abled covers Basavakalyan, Chitguppa, and Humnabad Taluks of Bidar district in Karnataka. Presently the program targets Persons with Mental Illness with an inclusive approach toward PwDs and Children with Developmental delays (0-6).

The aim is :

- o To integrate differently-abled persons into the mainstream of the society
- To help people with disabilities by promoting Disabled Persons' organizations (DPOs) for social integration, equalization of opportunities, and rehabilitation.
- To empower the differently abled persons by giving them guidance and awareness to make it work as a double-edged sword in changing the mindset of the public and the differently abled as well.

NAVAJEEVANA: Community Based Rehabilitation of Persons with Mental Illness

Goal

Mentally III persons get reintegrated into society, accessing their rights and entitlements and living an independent life.

Objectives:

- To identify PwMIs and assist to access free Psychiatric treatment and medication.
- To capacitate primary and secondary stakeholders through mental health training to bring about changes at the district and state levels.
- To ensure psychological, social, and economic independence among the PWMI to lead a dignified life.
- To ensure regular counseling to PWMI and their Carers.
- To train the carers to help the PWMI to practice ADL skills and management of side effects.
- To sensitize carers and stakeholders to understand the issues and needs of the PWMI.
- To ensure mass awareness among the general public on mental health to increase identification and referral systems.
- o To build Carers/ Parents champions for self-advocacy and to access social security.
- To ensure social inclusion of PwMIs by reducing social stigma through promoting livelihood opportunities to PwMIs and formation of DPOs with PwMIs/Caretakers.

Handholding to the path of wellness (names are changed for confidentiality)

Suresh is a 28 years old youth from Humnabad Taluk. He is the second son of Mr. Basava and Mrs. Susheela. He has an elder brother and a younger sister. His father is a worker in a local sugar factory and his mother is a teacher in a Private School in Humnabad. The socio-economic, and educational condition of the family is good. Parents



worked hard and did their best to make their children study well. Suresh's elder brother completed his undergraduate degree and is settled in life. His younger sister completed her Para Medical course and is trying for a job.

Suresh completed his Pre-University Course and joined Telephone technician training in Aurangabad - a town in the neighbouring State in 2015. He went for the course along with his friends. But he was trapped and cheated by his friends. Suresh's parents had given him Rs. 25,000/- for his training purpose. His friends asked him to give him some money, but he refused to give that money. His friends arranged a party cunningly and made to get drunk; they thrashed the drunken friend and took away all his money.

Suresh was shocked and traumatized by the cruel behavior of his friends. He could not complete his course; he dropped out of course and returned home. He never told to anyone about the incident or what happened to him. But he went into depression because he suppressed everything in his mind and worried about it. After some days his mental health became so bad, that he started going out of his home roaming everywhere, scolding his family members, people in the neighburhood, and so on. He used to get angry with everyone, laughed and talked to himself and, refused to take bath and change the histy dress. But the family could not understand the reason.

Observing his behavioral changes, his parents took him to a private Mental Health care hospital in the next district for treatment. He was under treatment from 2015-18 in private and government hospitals in Gulbarga and Shivamogga spending a lot of money. Suresh showed some improvement. At that time he shared what happened to him exactly - the whole incident of his friend's cheating and attacking him for money.

But his family discontinued his medication without the consultation of his doctor. It resulted in the relapse of his health. He returned to his old status. During the first phase of Navajeevana (2019-20), the staff identified the case and with the assistance of the local ASHA worker, reached Suresh to DMHP for treatment. But again, he dropped out of medication and became worse. The new staff member found his name in the list of relapsed cases and visited his house. The family was unwilling to bring him for treatment. But the Navajeevana staff did not give up; she pursued with patience; visited the family regularly and encouraged them to restart the medication.

During the Second Phase of Navajeevana (2021-22) Training on Field-Based Home Care in Nov 2021, Navajeevana team selected Suresh as a Challenging case and visited the family along with the resource person. The resource person explained the possible threats of his future. Finally, they agreed to resume the treatment. Navajeevana staff went to Suresh's family and brought him along with his mother for the first visit to the DMHP camp.

Since then, Suresh is regular for his medication. There is a lot of improvement in him now. Suresh started going for work daily, earns Rs 500/- per day, gives the money to his mother; he is regular for his medicine at DMHP camp, by himself.

Early Intervention & Early Education for the children with Developmental Delay.

Early Intervention & Early Education is the project to identify and enhance the normal development to **infants and toddlers at risk of developmental delays**. Children below seven years of age may suffer from delays in five developmental areas. These are physical, cognitive, communication, social or emotional development, sensory and adaptive development.

Goal & Objectives

- ➢ Early Identification
- > Children from 3-6 years will show confidence and enjoy their right to education.
- Families understand their children's strengths, abilities and special needs and support their children to develop and learn.
- > Ensure that the Children with Development delays receive support services
- Sensitization of other stakeholders on early identification & intervention among children with disabilities
- Government departments at Taluk level and district level extend their support for the effective implementation of EI & EE programme.

3 Days Workshop on Assessment of Children with Developmental Delay

ORBIT in collaboration with AKSHADHAA Foundation organized an Assessment camp for children with Developmental Delay for Early Intervention on 15.2.2022. Children with different types of developmental delay were brought and assessed. 26 children participated in the camp. The parents were instructed on follow up required.

Ms. Sumana Datta, co-foundress of AKSHADHAA and her three-member team assessed the children.

The staff of Early Intervention & Early Education makes regular house visits to the Children with Developmental Delay in Humnabad and Chitguppa Taluk and instructs and motivates the parents on the exercises needed for the children; government entitlement to be claimed. 62 children's families were visited regularly.

COVID - 19 PANDEMIC - Relief Work

ORBIT reached out to 12000 families of varied categories of life affected by the unprecedented lockdowns due to COVID -19 pandemic with the support of Azim Premji Philanthropic Initiatives (APPI) in collaboration with its 13 sub-centers & 33 other NGOs in the District.

With the collaborative efforts and hard work of volunteers from 33 NGOs and the sub-centers of ORBIT, 12000 food kits were packed and distributed in the first week of June 2021 from two centres – ORBIT Humnabad and St. Joseph's PU College, Bidar.

Skill Development and Income Generation Program (SDIGP)

In order to empower the youth and women who are unemployed and unskilled, ORBIT organizes skill development programs on Driving, Garment Making/Tailoring, Rexene Bag making, Beautician, Paper bag making, Basic computer, etc.

Objectives:

- To improve livelihood security.
- Enhanced productivity of vulnerable and backward communities by developing skills and assets.
- Promoting greater income generation and vocational training opportunities.
- Promotion of micro credit units to promote the business and growth.
- Empowering people to self-manage and run their own livelihood with their own capabilities.

ORBIT has given focus to the skill development of rural women and youth in various villages of all three Taluqs of Bidar District, during the year 2021-22. Total 78 persons were given skill development training. Along with the skill trainings, the trainees were given additional input sessions on various life skills such as RTI Act, etiquette, Gender Sensitivity, health & hygiene, HIV/AIDS, Communication, leadership, Child Rights, etc. besides the Entrepreneurship Development workshop.

Success Story- 1: Skilled to be employed

Jeevan S/o Thukkaram is a 32 years old slum dweller from Bidar. He is the youngest among the four sons of his parents. He studied up to 7th standard. His family has been sustained by his father who has an old auto rickshaw. His brothers used to drive the auto as they grew up. Jeevan too learned a little bit of driving but could not go to the city since he was not adept and did not have a Driving license. So, he used to go for other coolie work, such as tiles fixing, helper to mason and earn an average Rs. 400/-. When got married 5 years ago and the child was born, his income was insufficient to support the family. His elder brothers had been settled and lived in separate houses. Jeevan had to support his parents, wife and two children with his limited income. So, he could not think of learning driving and getting license by paying minimum Rs. 8,000/-.

Hence, Jeevan was extremely excited to get admission to the one month driving course offered by ORBIT and to get the driving license. He joined the training and enthusiastically completed the training. He secured the license.

Presently, he is driving his father's old auto rickshaw and earns an average Rs. 600/- per day. During the summer season the income goes up to 1,000/- per day. He also takes children to the school on regular basis.



Success Story- 2: House wife to Beautician



Ms. Ashritha from Haleyabura village of Bidar Taluk is a young woman of 32 years, educated up to PUC. She was married to Shanthakumar and has two children aged 10 and 4. They were settled in the village in the beginning years of their marriage and were able to manage the income of her husband. Shanthakumar is a journalist in a newspaper and to travel to and from the town for his job was difficult. They also desired to give better education to the children by sending them to the private schools in Bidar. So the couple shifted to a rented house in Jerusalem

colony in Bidar town, 6 years ago. The cost of living increased for them as they had to pay Rs. 3,000/ per month for rent; pay the fees of the eldest daughter and the expenses of one more member of the family as a daughter was born. The sole income of Shanthkumar was insufficient to meet the ends of the family. Leaving the baby behind, Ashritha could not go to any work.

Meanwhile, she was encouraged by the information from her SHG about the two months Beautician course being conducted in the nearby street by ORBIT. Very enthusiastically, Ashritha took the admission for the course and learned well.

Though she wanted to begin her own beauty parlor, she did not have the financial strength. At the same time, she went for bridal make-up to houses and earned an average Rs. 3,000/- to Rs. 4,000/- per make-up, besides the regular income of small work she got at home.

Assessing her expertise and enthusiasm, ORBIT entrusted one of its beautician courses to be conducted at her house. Presently, she is a teacher for two months' beautician course with 12 trainees. She gets a salary Rs. 6,000/- and the income from her customer service too. Her experience sharing is an inspiration for her trainees too.

Ashritha and their family is happy and grateful for the radical change in her life as she has become a strong support for the family income along with her husband.
